Dawda Badgie, Council member for Burkina Faso, Cabo Verde, Chad, Guinea-Bissau, Mali, Mauritania, Niger, Senegal, and The Gambia, is the designated as Elected Chairperson for the calendar year 2024 by decision 29/2023 adopted on December 19, 2023.

- b. Request the Secretariat to develop additional options noted in the document, such as set asides for agency groups with greater engagement needs, the development of incentive mechanisms, and a targeted outreach program in alignment with the Country Engagement Strategy, for consideration by Council at a future meeting

#### **Decision 51/2024** Report of the Selection and Review Committee

  - c) Takes note of Fiscal Year 25 mid-term assessment goals for both the GEF CEO and IEO Director and requests the SRC to present their performance evaluations at the 69th Council meeting.

52. In accordance with paragraph 24 of the <u>Council Rules of Procedure</u>, *Agenda item 13. GEF-8 Midterm Review on Performance of Full Flexibility* will be included in the provisional agenda of the 69th GEF Council for discussion next June.
