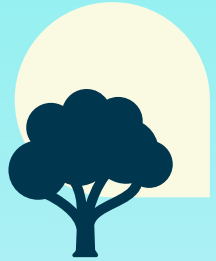

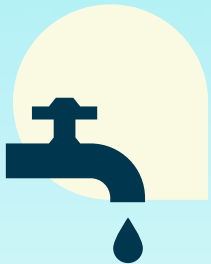

# Recommended Council Decision

The Council, having reviewed document GEF/LDCF.SCCF.36/E/01, “FY25 Program and Budget for the Independent Evaluation Office of the GEF under LDCF and SCCF,” approves the annual budget of \$347,788 to carry out the work program for fiscal year 2025. The budget is in line with the term of the evaluation work, which spans multiple years. The approved budget is being distributed as follows:

1. \$203,073 from the Least Developed Countries Fund (LDCF) and
2. \$144,715 from the Special Climate Change Fund (SCCF)
