QUALITY ASSURANCE PEER GROUP (QAPG) OF OPS4 Approach and work plan April 20, 2009

Introduction

This document sets out the key elements of the Quality Assurance Peer Group (QAPG) of OPS4. It describes the background of the Group, its purpose, the scope and general approach and methods, the composition of the Group and the time schedule. This document serves as a basic reference guide for the review to be undertaken.

Background

The Third Assembly of the GEF held in Cape Town, South Africa, in August 2006 requested the GEF-Council to ensure the preparation of a fourth overall performance study (OPS4) of the GEF for submission to the next assembly meeting. In June 2007, the GEF Evaluation Office proposed to the Council to undertake the Fourth Overall Performance Study as part of its regular work program. The Council approved the principle that OPS4 would be managed and implemented by the Evaluation Office, except for study components that would pose a conflict of interest. Work for the OPS4 started in 2008 and is scheduled to continue until September 2009 when the OPS4 Final Report will be presented to the Replenishment Meeting. The Evaluation Offices of the GEF Agencies were invited in December 2008 to be part of a Quality Assurance Peer Group, on a voluntary basis.

Purpose

This task builds on previous experience of collaboration between the GEF Evaluation Office and the Evaluation Offices of the GEF Agencies, such as the joint evaluations of the GEF Activity Cycle and the Small Grants Programme. The purpose of the review is to provide the GEF Evaluation Office with an independent perspective on the quality of methodologies and data being used for the OPS4.

Subject and Scope

The group will review relevant OPS4 documents to provide a peer review perspective during the OPS4 process.

The group will examine and comment on:

1. OPS4 Methodology
2. OPS4 data and information used for analysis
3. Draft of OPS4 Interim Report
4. OPS4 sub studies and case studies
5. Draft of OPS4 Final Report
